This rule establishes the number of hours per month which constitutes the standard work month for members of the West Virginia State Police who are exempt from Federal Labor Standards Act guidelines and designates the criteria for receipt of a portion or all of the supplemental payment when hours are worked in excess of the standard work month.

This rule prescribes the requirements for the issuance and termination of authorization for retired and medically discharged members of the West Virginia State Police to carry handguns and sets specific requirements for the type and condition of any handgun carried under the provisions of this rule.

- 3.3 "Public Record" includes any writing containing information prepared or received by a public body, the content or context of which, judge either by content or context, relates to the conduct of the public's business which are proposed, owned and retained by the West Virginia State Police, and which are not held in confidence pursuant to federal or state laws.
- 3.4 New Definition "Writing" includes any books, papers, maps photographs, cards, tapes, recordings or other documentary materials regardless of physical form or characteristics which are proposed, owned and retained by the West Virginia State Police, and which are not held in confidence pursuant to federal or state laws.
- 6.1 (add this wording to the end) The department may not charge a search or retrieval fee or otherwise seek reimbursement based on a man-hour basis as part of costs associated with making reproduction of records.

When, during an offender match confirmation, it is determined that the matching offender sample does not meet the requirement of the Chapter 15-2B the offender information will be released as part of the match confirmation process. Upon completion of the match confirmation process, if the individual has no other qualifying offense, the offender sample will be administratively removed from CODIS and the DNA Database.

Changes to the duties of the State Police (sections 13.5.a, 13.10, 13.11).

Additional changes regarding sending certified mail are necessary (section 17.5.b).
